

## Emergency Paid Sick Leave Tracker: State, City, and County Developments

In response to the COVID-19 pandemic, states, cities, and counties throughout the U.S. have acted to protect workers affected by the virus by enacting emergency paid sick leave policies. This document tracks emergency paid sick leave measures at the state and local level, and it will be updated with new developments periodically; please note that this document is *not* exhaustive. Beyond a few examples, this document does not provide a comprehensive tracking of local and state emergency leave policies that only pertain to state or local government workers.
